

MEMORANDUM OF UNDERSTANDING BETWEEN

IBEROAMERICANA (UNIBE) AND THE UNESCO JANUSZ KORZCZAK CHAIR at
the MARIA GRZEGORZEWSKA UNIVERSITY in Warsaw

Universidad Iberoamericana (UNIBE) acknowledges that it is a private, nonprofit Institution of Higher Education, approved and authorized by The Dominican Ministry of Higher Education, Science and Technology (MESCyT) and has been in operation and good standing since 1982 in Santo Domingo, Dominican Republic. UNIBE will be represented by Dr. Julio Amado Castaños, Rector.

THE MARIA GRZEGORZEWSKA UNIVERSITY (APS) acknowledges that it is a public funded Institution of Higher Education, approved and Authorized by the Ministry of Science and Higher Education, founded in 1922, has been in operation and good standing since. APS will be represented by Prof. Stefan Kwiatkowski, Rector.

The parties wish to establish a spirit of shared cooperation and to build long-term relationships for the benefit of their institutions, students, faculty, researchers, and respective communities.

In order to promote cooperation between **Universidad Iberoamericana**, Dominican Republic and **The Maria Grzegorzewska University** the two institutions agree to encourage direct contact and cooperation between their students, faculty, research, and administrative staff.

Within fields that are mutually acceptable, the following general forms of cooperation will be pursued:

- Cultural initiatives
- Study abroad programs
- Internships
- Student and Faculty exchange programs


- Exchange of information including, but not limited to, exchange of library resources and research publications that are open access or whose sole proprietorship belongs to UNIBE.
- Collaborative Research activities
- Joint collaborative grant proposals
- Collaboration on Continuing Education programs and Certificates
- Capacity building and collaboration on graduate programs

Both parties understand that all financial arrangements will have to be negotiated and agreed upon with due regard to the availability of funds and other resources.

Specific details for the implementation of these activities will be developed mutually for specific projects and faculty or administrative personnel will be appointed by the parties to follow up on each project.

The Memorandum of Understanding envisages that there will be a specific subsidiary contract in writing for each particular project.

The present agreement will become effective from the date the contract is signed and will be valid for one year; it will then be tacitly renewed from year to year, unless notice of termination of the agreement is given by one of the two parties by mutual written consent or by thirty (30) days notice in writing by either of the two parties with due regard to the contractual commitments in terms of specific contracts.
